There have been a considerable number of consultations over the period of the report. The quantity of housing development and proposed road building and highway improvements continue to be major issues for access in West Sussex.

# Higher Level Stewardship (HLS) Access

All paths in West Sussex within this scheme were inspected to determine which would be of most benefit to add to the access network and would therefore be best to retain if possible. It is intended to contact the relevant landowners to discuss the possibility of retaining this additional access to the countryside.

# A281/Downs Link Crossing

It has been a long-term aim of WSLAF to improve the safety of the Non-Motorised User (NMU) crossing over this busy trunk road. The Forum have been in contact with WSCC over many years and investigated the possibility of improving sight lines, moving speed limit positions and signage to drivers, and pushed for the installation of a signalised crossing. Tragically, a cyclist fatality occurred at the crossing in July 2020 and the Forum will be providing a statement to the Coroner of WSLAF's involvement with this situation.

# Rampion 2

WSLAF have a representative in the PRoW Project Liaison Group who are involved with monitoring and commenting on the effects of the proposed cable laying route on the access network to ensure access is maintained as far as possible during the works and reinstatement to a high standard is undertaken on completion.

## **Looking Forward**

The scale of proposed housing development and new road proposals show no sign of diminishing throughout West Sussex. The Forum will continue to provide independent and balanced comment and advice to improve and maintain access for all.

We will continue to take a pro-active interest in all proposals and developments to improve the A281Downs link crossing. The Forum will also continue with scrutinising the implications for access of the Rampion 2 Wind Farm development.
