NOTICE is hereby given that West Sussex County Council proposes to introduce a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce a 20mph speed limit on lengths of Chichester Road, Church Hill, Duck Lane, Edinburgh Square, Grange Road, Knockhundred Row, Market Square, Red Lion Street, St Annes Hill, Selham Road, Sheep Lane, South Street, West Street, The Wharf and Wool Lane.

Statement Of Reasons For Proposing To Make The Order

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order, the effect of which will be to introduce a 20mph speed limit on lengths of Chichester Road, Church Hill, Duck Lane, Edinburgh Square, Grange Road, Knockhundred Row, Market Square, Red Lion Street, St Annes Hill, Selham Road, Sheep Lane, South Street, West Street, The Wharf and Wool Lane.

A Speed Reduction community highway scheme is being progressed to introduce a 20mph speed limit in Midhurst village east of the A286. The 20mph speed limit will apply on roads within the old town area.

The scheme consists of 20mph signage and 20mph roundel markings, including some resurfacing on Selham Road at its junction with Chichester Road to allow for the application of a 20mph roundel marking.

This is to with a view to improving road safety for all road users, reducing air and noise pollution and improving the overall environment.

This Order is proposed so as to reduce danger to persons or other traffic using the road or to minimise the likelihood of any such danger arising and for facilitating the safe passage of any class of traffic (including pedestrians).

Drawing CHI2402: Midhurst & West Lavington Proposed Speed Limit (23.05.2024) shows the lengths of roads, which are the subject of the proposed order.

West Sussex County Council in exercise of their powers under Sections 82 (2), 83 (2) and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order shall come into operation on the X day of X 202* and may be cited as "West Sussex County Council (Midhurst & West Lavington: Chichester Road, South Street & Various Roads) (20mph & 30mph Speed Limit) Order 202*"
- 2. The Orders in the First Schedule to this Order are hereby revoked.
- 3. The lengths of restricted roads in the Second Schedule to this Order shall cease to be restricted roads for the purpose of Section 82 of the Act.
- 4. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour on the lengths of roads specified in the Second Schedule to this Order.
- 5. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour on the lengths of roads specified in the Third Schedule to this Order.
- 6. Nothing in Paragraphs 4 and 5 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when
 - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
 - (b) the vehicle is being driven-
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds.
