NOTICE is hereby given that West Sussex County Council propose to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on:-

- (i) both sides of Jarvis Lane from Castle Lane north-eastwards to Jarvis Hall;
and
- (ii) the east side of High Street adjacent to the access to Wykeham Close.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on:-

- (i) both sides of Jarvis Lane from Castle Lane north-eastwards to Jarvis Hall;
and
- (ii) the east side of High Street adjacent to the access to Wykeham Close.

Vehicles parking in too close proximity to the junction of Jarvis Lane with Castle Lane and opposite Jarvis Hall force larger vehicles to have to mount the pavement and restrict the free-flow of traffic. The Parish Council submitted a TRO application on behalf of the local community to address these issues.

The existing waiting restrictions are insufficient. Vehicles frequently mounting the pavement are creating a safety hazard for pedestrians and overtime will cause damage to the highway infrastructure. The Fire and Rescue Service have confirmed that waiting restrictions in this location would improve access in the event of an emergency. It is proposed to introduce lengths of double yellow lines on both sides of Jarvis Lane.

The opportunity is being taken to address an access issue being created with vehicles routinely parking on an Access Protection Line and hatching on the east side of the High Street. It is proposed to introduce formalised waiting restrictions in this location with a length of double yellow lines.

The proposed waiting restrictions aim to better facilitate vehicular movement and access on the carriageway whilst keeping parking displacement to a minimum.

This Order is proposed to avoid danger to persons or traffic using the road or for preventing such danger from arising, for preventing damage to the road and for facilitating passage on the road of any class of traffic (including pedestrians).

1. This Order shall come into operation on the X day of X 202* and may be cited as "West Sussex County Council ((Horsham District) (Parking Places and Traffic Regulation) (Consolidation No. 2) Order 2006) (Jarvis Lane & High Street Amendment) Order 202*."
2. The "West Sussex County Council (Horsham District) (Parking Places and Traffic Regulation) (Consolidation No.2) Order 2006" is hereby amended by the deletion from it of the plan specified in the First Schedule to this Order and the substitution of the plan attached in the Second Schedule to this Order.

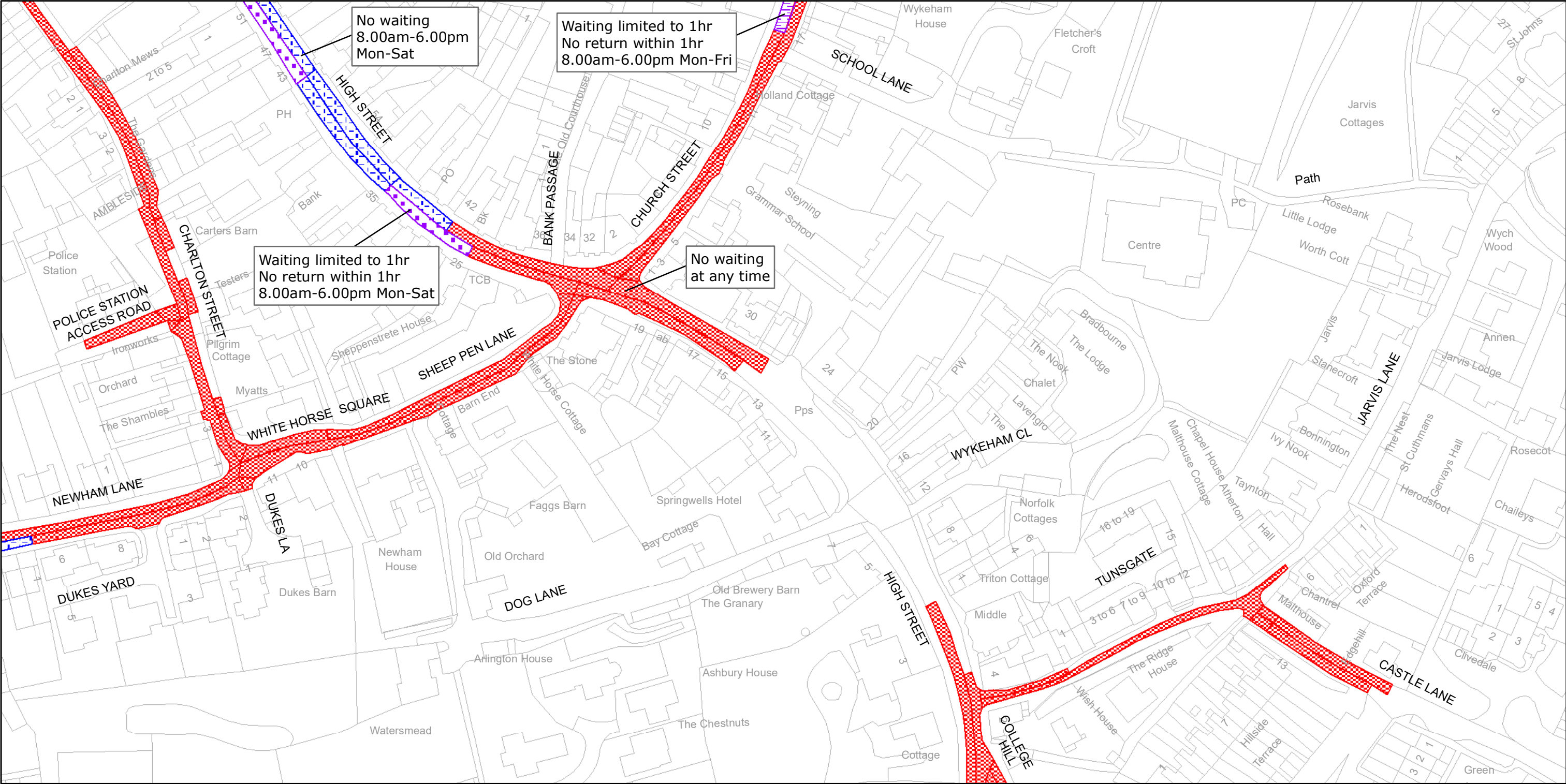
