NOTICE is hereby given that West Sussex County Council propose to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on both sides of Friston Walk in and around the junction with Ifield Drive and on the south-west side of Friston Walk from Ifield Drive north-westwards for a distance of 70 metres.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on both sides of Friston Walk in and around the junction with Ifield Road and on the south-west side of Friston Walk from Ifield Drive north-westwards for a distance of 70 metres.

Friston Walk is a residential cul-de-sac in close proximity to St Margarets Church of England Primary School. The road has a narrow width and serves as the only access to numerous properties and flats. At school drop off and collection times vehicles are routinely parking on the bend access to the road as well as parking on footways and verges which can cause traffic conflict. This has resulted in school children walking in the road to access the schools as well as obstructing vehicular access for residents of Friston Walk. There are reports of vehicles having to reverse back out onto Ifield Road when faced with oncoming traffic trying to exit Friston Walk. The Council received a request to address this issue.

To alleviate the localised obstruction and access difficulties it is proposed to introduce lengths of double yellow lines around the junction of Friston Walk and Ifield Drive and a length on one side of Friston Walk. The restriction aims to ensure that both drivers and pedestrians have more forward visibility to pass safely.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenity of the area through which the road runs.

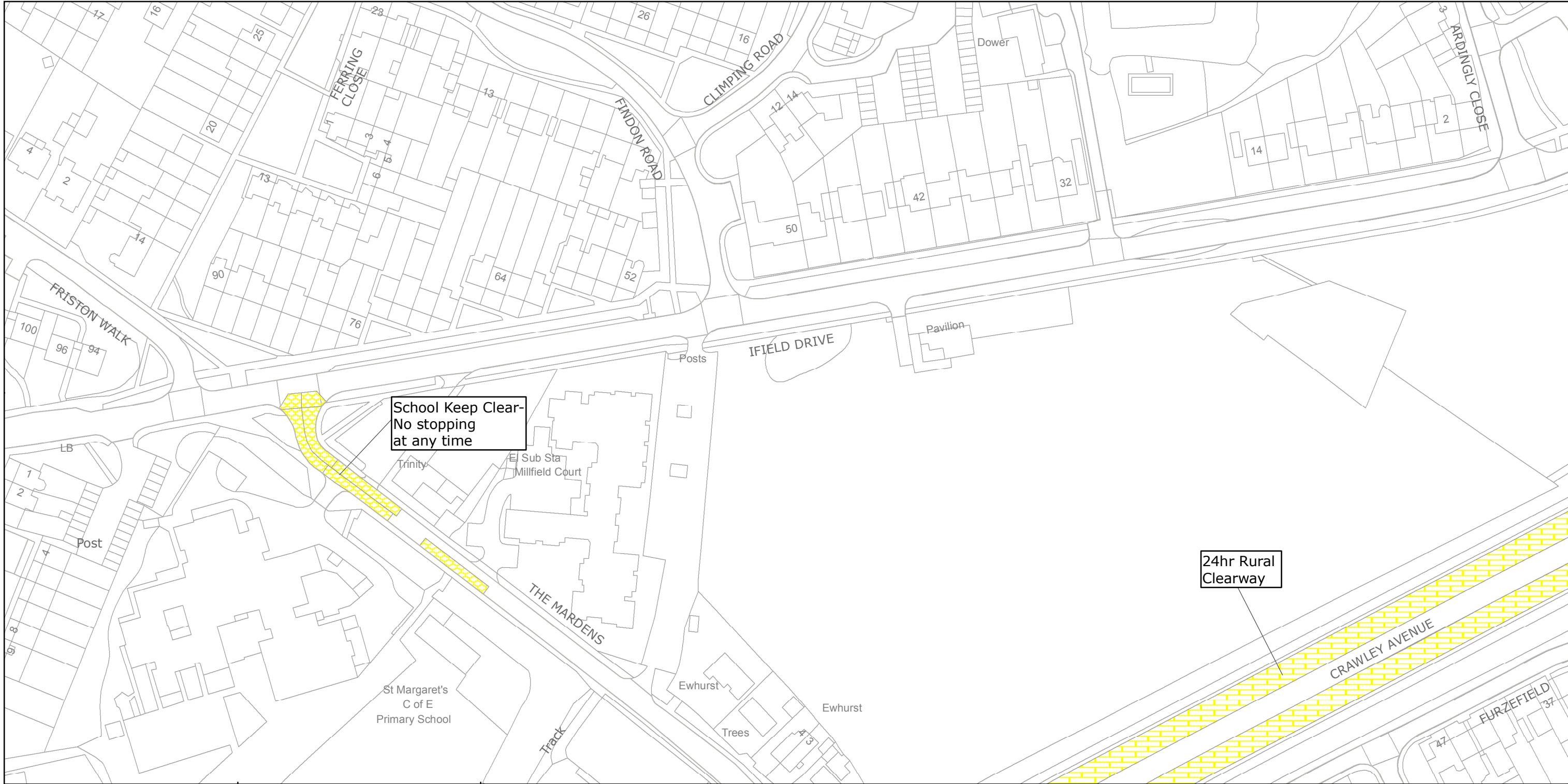
