NOTICE is hereby given that West Sussex County Council proposes to introduce a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce:-

- (i) a 20mph speed limit on lengths of the A286, Charlton Road, Church Lane, Church Road, Cobblers Row, The Grove and The Leys, and
- (ii) a 30mph speed limit on lengths of the A286 and Town Lane, and
- (iii) a 40mph on a length of the A286.

Statement Of Reasons For Proposing To Make The Order

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order, the effect of which will be to introduce:-

- (i) a 20mph speed limit on lengths of the A286, Charlton Road, Church Lane, Church Road, Cobblers Row and The Grove, and
- (ii) a 30mph speed limit on lengths of the A286 and Town Lane; and
- (iii) a 40mph speed limit on a length of the A286

A community highway scheme is being progressed that looks to increase pedestrian and road user safety, improve pedestrian links across Singleton village, and address the accessibility issues at the northbound village bus stop.

As part of the scheme it is proposed that the speed limit in Singleton is reduced from 30mph to 20mph. The 20mph speed limit will apply on roads within the defined village centre.

To avoid the speed limit changing from national to 20mph this scheme has been designed with a 30mph buffer zone on the Town Lane northbound approach. On the A286 eastbound approach to the village the speed limit will be reduced from national speed limit to 40mph between West Dean and Singleton, with a 30mph buffer zone for a distance of 400 metres before the 20mph in Singleton village centre.

To aid compliance with the 20mph speed limit the design includes speed reducing measures. These are, village wide roundels, yellow backed terminal signs and village gateways, red surfacing at entry points, and a horizontal deflection pinch point at the bus stop. The existing Vehicle Activated Sign will be updated to the 20mph limit.

The existing 30mph speed limit on the A286 will be extended 40 metres west of the village gateway. A yellow-backed terminal sign will be supported by a roundel and red high fiction surfacing. The 30mph speed limit on Town Lane will be extended south of the village gateway. The proposed location improves visibility and allows drivers more deceleration time before reaching the entrance to the Weald and Downland Museum

This Order is proposed so as to reduce danger to persons or other traffic using the road or to minimise the likelihood of any such danger arising and for facilitating the safe passage of any class of traffic (including pedestrians).

West Sussex County Council in exercise of their powers under Sections 82 (2), 83 (2) and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

- This Order shall come into operation on the X day of X 202* and may be cited as 1. "West Sussex County Council (Singleton: A286, Charlton Road & Various Roads) (20mph, 30mph and 40mph Speed Limit) Order 2024"
- 2. The Orders in the First Schedule to this Order are hereby revoked.
- No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles 3. per hour on the length of road specified in the Second Schedule to this Order.
- No person shall cause or permit any vehicle to proceed at a speed exceeding 30 4. miles per hour on the length of road specified in the Third Schedule to this Order.
- 5. No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour on the length of road specified in the Fourth Schedule to this Order.
- 6. Nothing in Paragraphs 3, 4 and 5 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when -
 - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
 - (b) the vehicle is being driven-
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds.
