STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce short lengths of prohibition of waiting at all times (double yellow lines) on sections of both sides of Ginhams Road between Ewhurst Road and The Twitten.

Ginhams Road is a residential road in close proximity to Crawley Hospital and on the periphery of a Controlled Parking Zone. Consequently demand for on-street parking is high and causes localised obstruction and access difficulties. The road has a narrow width and is an access road to residential properties including a sheltered housing accommodation. Vehicles are frequently parking on the grass verge as well as parking on footways. This can obstruct forward visibility for other drivers and pedestrians and also deters children from playing safely on the central grass verge area. The Council received a request to address this issue.

To alleviate the problem, it is proposed to introduce short lengths of double yellow lines on both sides of Ginhams Drive between Ewhurst Road and The Twitten. It is proposed to introduce a parking restriction so that drivers and pedestrians have better forward visibility to pass safely. The parking restriction will deter parking on the carriageway, footway and verge in those locations where it creates an obstruction. This will improve visibility for all road users and the safety of pedestrians and children.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenity of the area through which the road tuns.






PAGE 1 OF 2: EXISTING RESTRICTIONS ONLY
