This Order is made by the County Council of West Sussex under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the Chanctonbury Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) and Section 53(3)(c)(ii), namely, that a right of way which is not shown in the Map and Statement subsists or is reasonably alleged to subsist over land in the area to which the map relates and being the discovery of evidence which shows that a highway shown on the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The West Sussex County Council has consulted every local authority whose area includes the land to which the order relates. The West Sussex County Council hereby orders that:

1. For the purposes of this Order the relevant date is the 20th December 2024.
2. The Definitive Map and Statement for Chanctonbury shall be modified as described in Part I and Part II of the Schedule and shown on Order Plan 01824 as attached to this Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the West Sussex County Council (Chanctonbury No. 2: Henfield and Woodmancote (Addition of a Bridleway and upgrade of Footpath 2540 to a Bridleway)) Definitive Map Modification Order 2025.

PART I

Modification of the Chanctonbury Definitive Map

Description of path or way to be added

A bridleway commencing at bridleway 2540 (grid reference 523481,116043) and proceeding in an easterly direction for 460 metres to Blackstone Lane (grid reference 523934, 116004) as shown by the broken diamond point line between the points marked B and C on Order Plan 01824 and with a minimum width of 5 metres.

Description of public right of way to be upgraded

And the upgrade, to a Bridleway, of a section of footpath 2540 from its commencement on Furners Lane (grid reference 521739, 116150) to where the path leaves Furners Lane (grid reference 523481,116043) as shown by the diamond point line on the Order Plan 01824 marked points A to B and with a minimum width of 4 metres.

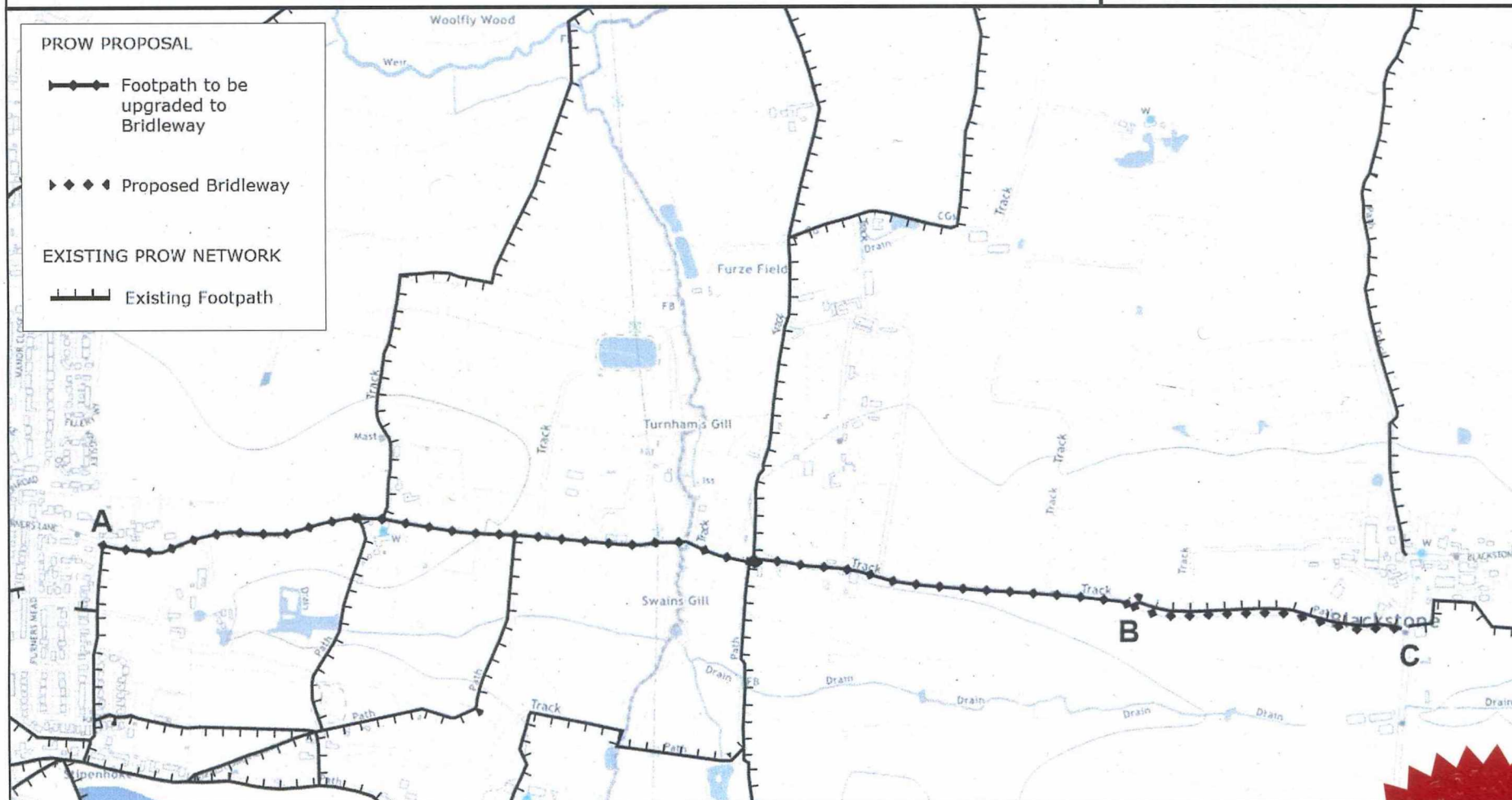
