## Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce a parking restriction limiting waiting to 1 hour, no return within 2 hours Mon-Sat in the currently unrestricted parking bays at the junction of High Street with The Square in Angmering.

Angmering Parish Council has applied for the proposed restriction under WSCC's community Traffic Regulation Order process. There is concern that the un-restricted parking area is often used by long staying vehicles, taking up parking places that would be better used for short staying visitors to the shops at this location.

The new order is therefore proposed to preserve or improve the amenities of the area through which the road runs.

The attached drawing, numbered TQ0604SEN shows the lengths of roads affected by the proposed order.
