Introduction

Previously looked after children are children who were looked after but ceased to be so because they were adopted or became subject to a child arrangements order or special guardianship order. Service children are children of service personnel with a confirmed posting to the local area or crown servants returning from overseas to live in the local area.
2.	Children with known medical or social needs who would benefit from a place at the school.
3.	Children who will have a sibling attending Nyewood CE Junior School at the time of admission.
4.	Children who at the time of application are in Year 2 at Nyewood CE Infant School.
5.	Children of parents who are regular worshippers at St Richard (Aldwick), St Wilfrid (Bognor), St Thomas A'Becket (Pagham), or Holy Cross (North Bersted) Churches.
6.	Children by distance from the school with priority for admission given to children who live nearest to the school within a defined area as agreed with the Local Authority.

2.	Siblings of children on the roll of St Joseph's CE Junior and St Joseph's Infant School at the time of admission.
3.	Children of parents who have been members of staff at St Joseph's CE Junior School continuously for the two years prior to the application for admission; or staff recruited to fill a vacant post for which there is a demonstrable skill shortage.
4.	Children or families with an exceptional medical and / or social need. Supporting evidence from a professional is required such as a doctor and / or consultant for medical needs or a social worker, health visitor, housing officer, the police or probation officer for social needs. The evidence must confirm the child or family's medical or social need and why that makes it essential that the child attends the school / academy rather than any other. If evidence is not submitted by the application deadline, the medical and / or social need cannot be considered.
5.	Children living within the community area that has been designated to the school / academy.
6.	Any other children.
