**NOTICE** is hereby given that West Sussex County Council proposes to introduce a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to reduce the speed limit to 40mph on the length of Stane Street from a point 205 metres east of Old Arundel Road, north-eastwards for a distance of 400 metres.

# Statement Of Reasons For Proposing To Make The Order

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to reduce the speed limit to 40mph on the length of Stane Street from a point 205 metres east of Old Arundel Road, north-eastwards for a distance of 400 metres.

A new access to the Rolls Royce Site on Stane Street Westhampnett has been constructed. The location of the access is beyond the extent of the 30mph village speed limit on an unrestricted length of Stane Street. During the planning process it was identified that the speed limit should be reviewed to ensure vehicles using the access have the appropriate visibility to enter and exit the site safely.

The speed limit has been assessed in accordance with the West Sussex Speed Limit Policy. To improve safe access and egress it is proposed to reduce the speed limit to 40mph on a 400m length of Stane Street. The 40mph speed limit will not only cover the access but will create a buffer length to provide transition to the 30mph speed limit on the south-west approach to Westhampnett village.

This Order is proposed so as to avoid danger to persons or other traffic using the road or to minimise the likelihood of any such danger arising and for facilitating the safe passage of any class of traffic (including pedestrians).

## WEST SUSSEX COUNTY COUNCIL (WESTHAMPNETT: STANE STREET) (40MPH SPEED LIMIT) ORDER 202\*

West Sussex County Council in exercise of their powers under Sections 82 and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

- This Order shall come into operation on the x day of x and may be cited as "West Sussex County Council (Westhampnett: Stane Street) (40mph Speed Limit) Order 202\*"
- 2. No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour on the length of road specified in the First Schedule to this Order.
- 3. Nothing in Paragraph 2 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when
  - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
  - (b) the vehicle is being driven-
    - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
    - (ii) for the purpose of training a person in driving vehicles at high speeds.
