## **Pilot Project**: SEND Banding Model for Mainstream Schools

West Sussex County Council is piloting a Banded Funding Model based on the identified common levels of support required to support an EHCP within a Mainstream School. This replaces the single fixed funding rate for all new EHCPs that are finalised during the pilot period. It aims to offer consistency and transparency of top up funding to schools at the outset, and is part of the SEND Improvement Program

Schools are expected to use up to £6,000 from their notional SEN budget for each pupil with an EHCP. If a pupil's EHCP outlines provision that costs more than this amount, schools can receive 'top up' funding.

Six bands will be tested, (including the use of notional budget) that offer increasing values of funding to represent complexity of need, and to help schools understand what type of provision should be in place. A 'Small Groups' band has been included in recognition of best practice and to reflect how schools are working with an increasing number of pupils with EHCPs.

			Where pupils are in the same key stage and have similar needs across Band C, D and E, schools are encouraged to look for opportunities to bring them together with a teacher as small groups. This enables schools to have a teacher-led, flexible response to meet the needs of groups of children, to include targeted and personalised support to enable learning inside of the mainstream classroom and increased support in unstructured time.
