STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce a length of prohibition of waiting at all times (double yellow lines) on the north-east side of Metcalf Way adjacent to the raised table.

As part of the highways scheme to improve sustainable transport provision in the Manor Royal area of Crawley, traffic calming measures were introduced in Metcalf Way, including a raised table 133 metres south-east of the junction with County Oak Way.

Current on-street parking in close proximity to the raised table is adversely affecting visibility for road users.

It is proposed to introduce a length of double yellow lines on the north-east side of Metcalf Way. The restriction will deter vehicles from parking either side of the raised table to alleviate the visibility issues.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians)






PAGE 1 OF 2: EXISTING RESTRICTIONS ONLY
