NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on lengths of both sides of St Floras Road in Littlehampton, south of its junction with St Floras Close. The Order also introduces formalised bus stop clearways south of St Floras Close, which prohibit stopping by any vehicle other than buses at any time.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the <u>West Sussex County Council website</u>. The website includes a response form for any comments or objections.

(Littlehampton: St Floras Road Amendment) Order 2025

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce double yellow lines on lengths of both sides of St Floras Road in Littlehampton, south of its junction with St Floras Close. The Order also introduces formalised bus stop clearways south of St Floras Close, which prohibit stopping by any vehicle other than buses at any time.

To improve pedestrian safety and access to local bus stops it is proposed to construct a new uncontrolled pedestrian crossing island on St Floras Road, immediately south of its junction with S Floras Close. The double yellow lines proposed by this Order are necessary to prevent parked cars from obstructing the new crossing island and to ensure pedestrians using it have a clear view of approaching traffic.

There are presently two uncontrolled bus stops on the affected length of St Floras Road and it is proposed to formalise these, creating bus stop clearways prohibiting stopping by any vehicle other than buses at any time. Presently parked cars at this location prevent buses pulling up to the kerb to pick-up or drop-off passengers, causing an obstruction to traffic. Providing formal bus stops will prevent this obstruction and avoid the need for passengers to negotiate parked cars when accessing the bus.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road, to facilitate the passage of traffic and to improve the amenities of the area through which the road runs.

The attached drawing, numbered TQ0302SES shows the length of road affected by the proposed order.




