NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce seven formalised parking bays (each bay of a size to accommodate several vehicles) in Loose Lane in Sompting. The Order also prohibits waiting at any time (introduce double yellow lines) throughout the remaining lengths of Loose Lane.

Notice is also hereby given that West Sussex County Council, under the provisions of the Highways Act 1980 (Traffic calming) Regulations intends to install a pair of raised speed cushion traffic calming features on Loose Lane in Sompting, immediately south of its junction with Peveril Close. These features will be 65mm in height and constructed in black McAdam.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the <u>West Sussex County Council website</u>. The website includes a response form for any comments or objections.

Sompting: Loose Lane: Traffic calming features 2024

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce seven formalised parking bays (each bay of a size to accommodate several vehicles) in Loose Lane in Sompting. The Order also prohibits waiting at any time (introduce double yellow lines) throughout the remaining lengths of Loose Lane.

It is also proposed to install a pair of raised speed cushion traffic calming features on Loose Lane in Sompting, immediately south of its junction with Peveril Close. These features will be 65mm in height and constructed in black McAdam.

Planning permission has been granted for a new residential development to be constructed on land to the west of Loose Lane. Access to the new development will be via Loose Lane. To ensure the additional vehicle movements on Loose Lane are accommodated safely, it is proposed to formalise parking arrangements throughout Loose Lane to a layout that will provide a traffic calming effect, in combination with priority give-way markings. The Order also prohibits waiting at locations where parked vehicles would obstruct the passage of traffic past the formalised parking areas.

The proposed speed cushions form part of this scheme of traffic calming and are intended to ensure vehicles travel at a safe speed on the southern approach to the priority give-way arrangement.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawings, numbered TQ1604NEN, TQ1604NES, TQ1604NWS and TQ1605SES show the parking restrictions proposed by this Order. Drawing number ITB12233-GA-039 shows the location of the proposed speed cushion features.
