NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) at the junctions of Hazelwood Close and Sandy Lane with Turners Hill Road in Crawley Down, in the parish of Worth.

**Statement of Reasons for Proposing to Make the Order**

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) at the junctions of Hazelwood Close and Sandy Lane with Turners Hill Road in Crawley Down, in the parish of Worth.

Local residents have raised concerns that parked vehicles obstruct the vision of drivers emerging from Hazelwood Close onto Turners Hill Road and have submitted a community request for a Traffic Regulation Order to resolve this problem. The opportunity is also being taken to resolve the same issue at the nearby junction of Sandy Lane with Turners Hill Road. A layout of double yellow lines to prohibit parking at the junctions has therefore been designed with the intention to ensure safe visibility while retaining parking where it is safe to do so.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawing, numbered TQ3337NEN shows the lengths of roads affected by the proposed order.

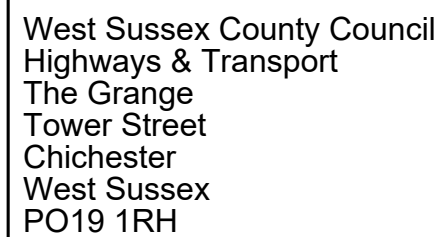
