NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) throughout both sides of Station Road in Angmering, from its junction with the A259, southwards to the double white carriageway centre lines at the railway level crossing.

(Angmering: Station Road Amendment) Order 2025

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) throughout both sides of Station Road in Angmering, from its junction with the A259, southwards to the double white carriageway centre lines at the railway level crossing. These double white lines already create a restriction which prohibits waiting on Station Road on the approach the level crossing.

Angmering Parish Council have applied for a community Traffic Regulation Order to address congestion caused by parked vehicles on Station Road, north of the railway level crossing. It is reported that parking on the unrestricted sections of Station Road obstruct the passage of traffic, particularly when traffic movement resumes after the level crossing gates re-open.

The new order is therefore proposed to facilitate the passage of traffic.

The attached drawings, numbered TQ0602NEN, TQ0602NWN, TQ0603SES and TQ0603SWS show the lengths of roads affected by the proposed order.






