NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) at the junction of Selby Court with Ashenground Road in Haywards Heath.

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) at the junction of Selby Court with Ashenground Road in Haywards Heath.

The Council has received a community Traffic Regulation Order application reporting that vehicles frequently park too close to the junction of Selby Court with Ashenground Road and that this restricts visibility and causes a hazard to passing traffic. An assessment of the application concluded that safety would be improved by the installation of double yellow lines to prevent this problem.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawings, numbered TQ3323SWS shows the lengths of roads affected by the proposed order.

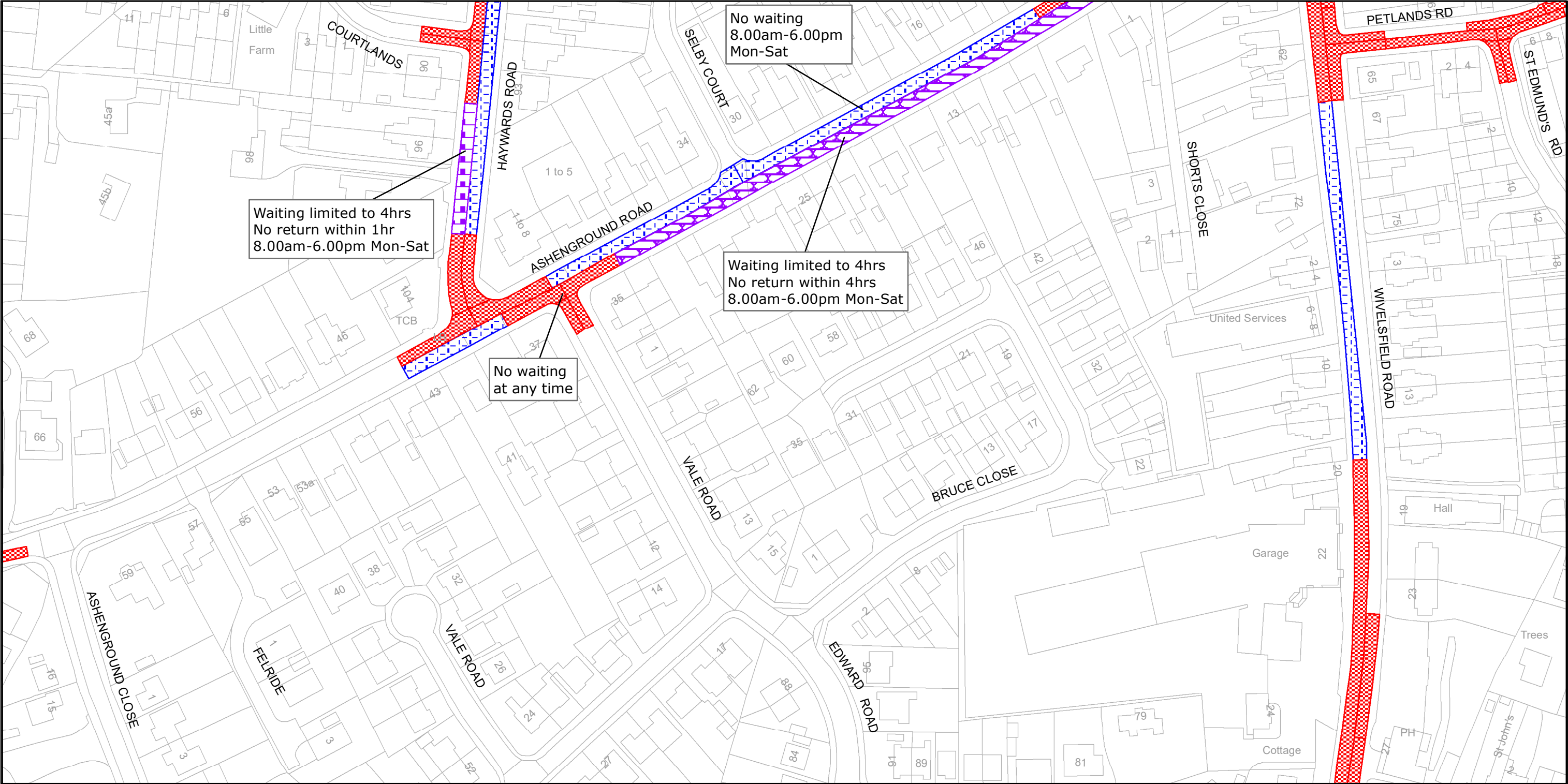
