NOTICE is hereby given that West Sussex County Council proposes to make two permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be as follows:

The first proposed Order would prohibit driving on Connaught Road in Littlehampton from its junction with Queens Street, eastwards to the eastern end of the road. The restriction would also apply to a short section of Queens Street from the southern kerbline of the western limb of Connaught Road, southwards to the southern end of the road. The restriction would operate from 0800 to 0930 and from 1430 to 1600 Mon-Fri with exceptions for access. The restriction enacts a 'School Street' on the affected lengths of roads.

The second proposed order would prohibit waiting at any time (introduce double yellow lines) on the northern side of Connaught Road from its junction with Queens Street eastwards to the existing 'School Keep Clear' marking. The restriction would also extend northwards along the eastern side of Queens Street for 6m.

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make two permanent Traffic Regulation Orders the effect of which will be as follows:

The first proposed Order would prohibit driving on Connaught Road in Littlehampton from its junction with Queens Street, eastwards to the eastern end of the road. The restriction would also apply to a short section of Queens Street from the southern kerbline of the western limb of Connaught Road, southwards to the southern end of the road. The restriction would operate from 0800 to 0930 and from 1430 to 1600 Mon-Fri with exceptions for access.

The second proposed order would introduce double yellow lines on the northern side of Connaught Road from its junction with Queens Street eastwards to the existing 'School Keep Clear' marking. The restriction would also extend northwards along the eastern side of Queens Street for 6m.

As part of the Government's Active Travel Fund initiative, the County Council is developing School Streets to promote active travel to schools. A 'school street' improves safety by preventing traffic from using roads at the entrance to schools during school pick-up and drop-off times. Riverbeach Primary School has been selected as part of this programme and highway improvement works are expected to begin in the February half term. This consultation therefore concerns the timing of the proposed prohibition of driving restriction and layout of associated parking restrictions remains subject to consultation. The Order would prohibit access for general traffic during its operative times, but allow access for residents at all times.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road.

The attached drawing, numbered TQ0202SEN shows the lengths of roads affected by the proposed new parking restriction. The drawing titled TRO Restriction Extends shows the length of road on which driving would be prohibited.

WEST SUSSEX COUTY COUNCIL (LITTLEHAMPTON: CONNAUGHT ROAD AND QUEENS ROAD) (PROHIBITION OF DRIVING) ORDER 2025

West Sussex County Council in exercise of their powers under Sections 1 (1) 2 (1) and (2), 4 (2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

PART 1 GENERAL

- 1. This Order shall come into operation on the ****** day of ****** 2025 and may be cited as "West Sussex County Council (Littlehampton: Connaught Road and Queens Street) (Prohibition of Driving) Order 2025" hereinafter called "this Order".
- 2. In this Order:-
 - "bus" means a motor vehicle constructed or adapted to carry more than 8 passengers or a "local bus";
 - "Local bus" means a Public Service Vehicle used for provision of a local service not being an excursion or tour;
 - "local service" has the meaning given in Section 2 Transport Act 1985;
 - "motor vehicle" has the meaning assigned to it in section 136(1) of the Act;
 - "Public Service Vehicle" has the same meaning as in Section 1 Public Passenger Vehicles Act 1981;
 - "traffic sign" means a sign of any size colour and type prescribed or authorised under or having effect as though prescribed or authorised under section 64 of the Act;
 - (2) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

PART 2 Prohibition of Driving Provisions

3. Save as provided in Article 4, no person shall cause or permit any motor vehicle to proceed in the length of road specified in the Schedule to this Order during the periods of 0800 to 0930, and 1430 to 1600 Monday to Friday.

- 4. Nothing in Article 3 shall apply to:
 - a. A vehicle being used by the Police, Fire Brigade or Ambulance Service in the event of an emergency; or
 - b. A vehicle being driven under the direction of a police officer in uniform; or
 - c. A vehicle being driven for the purpose of gaining access to a residential address located within the length of road specified in the Schedule to this Order; or
 - d. A vehicle being driven for the purpose of gaining access to or exiting from any business operating from premises located within the length of road specified in the Schedule to this Order; or
 - e. A vehicle located within the length of road specified in the Schedule to this Order before the commencement time periods in Article 3, being driven so as to leave the affected length of road; or
 - f. A bus being driven in the course of operating a local service; or
 - g. A motor vehicle being used in the course of providing school transport authorised by West Sussex County Council; or
 - h. A motor vehicle displaying a valid disabled persons' blue badge.
- 5. The prohibitions imposed by this Order shall be in addition to and not in derogation from any restriction imposed by any regulations made or having effect as if made under the Act or by or under an enactment.




