NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on Trinity Road in Hurstpierpoint opposite the spur road giving access to the Health Centre and at the entrance to the Health Centre car park.

The Order also prohibits waiting at any time in the turning head at the eastern end of Brown Twins Road and a short length of the same restriction along the frontage of no.9 Brown Twins Road.

#### (Hurstpierpoint & Sayers Common: Trinity Road and Brown Twins Road Amendment) Order 2025

#### Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce double yellow lines on Trinity Road in Hurstpierpoint opposite the spur road giving access to the Health Centre and at the entrance to the Health Centre car park.

The Order also prohibits waiting at any time in the turning head at the eastern end of Brown Twins Road and a short length of the same restriction along the frontage of no.9 Brown Twins Road.

West Sussex County Council has received a community TRO application raising concerns that parked cars obstruct safe access to the Health Centre in Trinity Road, Hurstpierpoint. Concerns have also been raised that parked vehicles at the eastern end of Brown Twins Road (which is a cul-de-sac) prevent traffic from using the turning head to exit the road.

The new order is therefore proposed to facilitate the passage of traffic.

The attached drawings, numbered TQ2816NWS, TQ2816SEN and TQ2816SWN show the lengths of roads affected by the proposed order.
