#### STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to extend the prohibition of waiting at any time (double yellow lines) on both sides of the A286 Bepton Road from the junctions with Ashfield Road and Pretoria Avenue westwards to Heathfield Gardens.

As part of the School Crossing Patrol Programme West Sussex County Council are looking to install a new uncontrolled crossing point on the A286 Bepton Road, Midhurst between Belloc Close and Heathfield Gardens. The crossing point aims to improve safety at the crossing location currently used by the school crossing patrol.

To improve visibility for those using the crossing it is proposed to extend sections of double yellow lines on both sides of Bepton Road west of the junctions with Ashfield Road and Pretoria Avenue to the junction with Heathfield Road.

The Order is proposed to avoid danger to persons or other traffic using the roads or for preventing the likelihood of any such danger arising, to facilitate the passage on the road of any class of traffic (including pedestrians).


