STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at any time (double yellow lines) in and around the junction of Elm Close and the B2198 Bracklesham Lane.

The Parish Council have submitted an application on behalf of the local community for some double yellow lines at the junction of Elm Close and Bracklesham Lane. The application raises safety concerns about vehicles parking in Elm Close in too close proximity to the junction affecting forward visibility for vehicles turning into and out of Elm Close. This creates congestion at the junction and results in traffic backing up on Bracklesham Lane. This impedes the flow of traffic on Bracklesham Lane which is the main route into the village.

The application has been assessed and double yellow lines are justified to deter parking in this unsuitable location.

The Order is proposed to avoid danger to persons or other traffic using the roads or for preventing the likelihood of any such danger arising and to facilitate the passage on the road of any class of traffic (including pedestrians).




