STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of both sides of Grattons Drive adjacent to Grattons Playing Field and around the bend towards Wadham Close.

Grattons Drive is a residential road, north-east of Crawley town centre. The road has a narrow width and as well as providing access to residential properties has a significant bend next to the community playing fields. Current on-street parking causes localised obstruction and access difficulties. Vehicles are frequently parking on both sides of the road which affects forward visibility for all road users. There are reported incidences of vehicles also parking on the footways and verges especially at school drop off and pick up times and at the weekends when sporting fixtures are taking place. The Council received a request to address this issue.

To alleviate the problem, it is proposed to introduce lengths of double yellow lines on both sides of Grattons Drive. The parking restriction will deter parking on the carriageway, footway and verge in those locations where it creates an obstruction. This will improve visibility for all road users and the safety of pedestrians and children trying to cross the road to the playing fields.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenity of the area through which the road tuns.






